

WHAT'S NEW IN LADDS?

Initial Interview Page:

1. Reason for Contact:

- "Crisis Intervention - Co-Dependent/Collateral/ACOA" was changed to "**Crisis-Intervention - Collateral**"

2. Addiction Type:

- "Tobacco" was deleted in the drop-down choices
- "None" changed to read "**None (For Children Only)**"

3. Abuse/Addiction Type:

- "**Oxycontin, Ecstasy, and GHB**" added in the list.

4. Frequency of Use:

- "Frequency Unknown" was deleted as one of the choices

5. Age of First Use:

- Enter "**96**" if no drug abuse is present, instead of "97"

6. Referral Source & Legal Status:

- Removed DWI 3rd & 4th from "Referral Source" and moved to "Legal Status"
- Changed "Court Order/DWI" to read "Court Order/DWI (1st and 2nd)"

7. Hide the names of **inactive interviewer.**

Termination form:

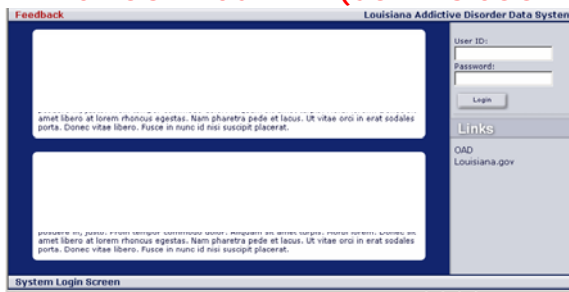
1. Treatment/Service Outcome:

Registry Info:

1. Change the label "Sex" to "**Gender**".

Initial Interview Page:

1. Change the label "Prior TX Episode (ADA)" to "**Prior SA Treatment**".
2. Delete "**History of Emotional Disorder**".
3. Change the label "Current Emotional Disorder" to "**Co-Occurring Status**".
4. Change "Self-Help Activities" to "**Self-Help Activities (Social Support of Recovery)**".
5. Disallow "Tobacco" to be used as primary drug use; label as "Tobacco (secondary/tertiary only)".
6. Group **ALL** Primary, Secondary & Tertiary Drug Use, Frequency of Use, Route of Administration and Age of First Use together.
7. Add "**Not Applicable**" to Route of Admin.

Financial Info:

1. Change the label "Primary Sources of Income" to "**Source of Household Income**".
2. Change "Medicare" to "**Medicare Number**".
3. Change "Medicaid" to "**Medicaid Number**".

Evaluation Form:

1. Change the label "Significant Emotional Disorder" to "**Co-Occurring Disorder**".

Service Ticket:

1. List Providers alphabetically by name
2. Delete the following data elements:
 - S11 - Time of Day
 - S12 - Community Collaboration
 - S13 - Appointment Status
 - S14 - Emergency On Call
 - S15 - Record Type
